MEMBER DUES STRATEGY POLICY CHANGE

WEF Membership Dues Strategy Policy Update. President elect Keith x and Treasurer Christine x provided an update to the staff as follow up to the presentation shared with the HOD at WEFTEC. The update included this slide .

Member Dues Strategy Policy Change

- The process for Member Dues increases was revised
 - Previous policy required 18-month timeline
 - New policy allows for up to a +3% annual dues assessment to be included in WEF's budget
 - WEF budget approved by Board in August; once approved, MAs will be notified of dues changes (effective January 1)
 - Special consideration can be made for Operators, YPs
- New policy effective FY25 (Board will approve FY25 budget August 2024)

WEF BYLAWS PROPOSED UPDATES APPROVED BY HOUSE OF DELEGATES

The HOD officially voted to confirm proposed updates to the WEF Bylaws during their quarterly meeting held on December 13th. The approved changes are related to the Board Committees, including formalizing the Ethics Committee, removing the WEFTEC Advisory Committee, and shifting existing Subcommittees to Committees; as well as adjustments to the text related to the Member Engagement Transformation (MET).
