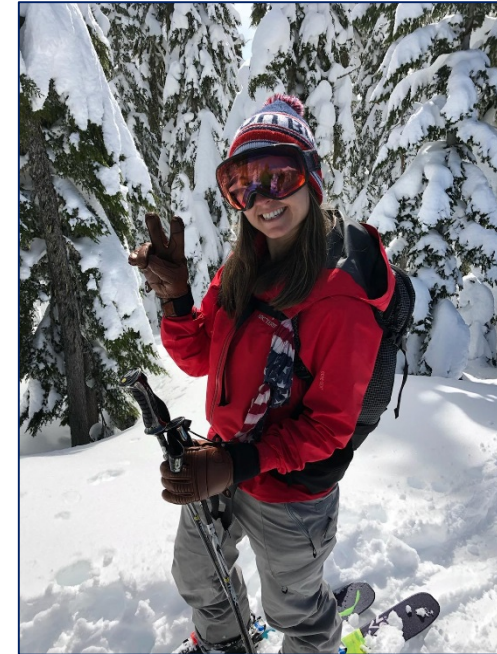
How I got here....

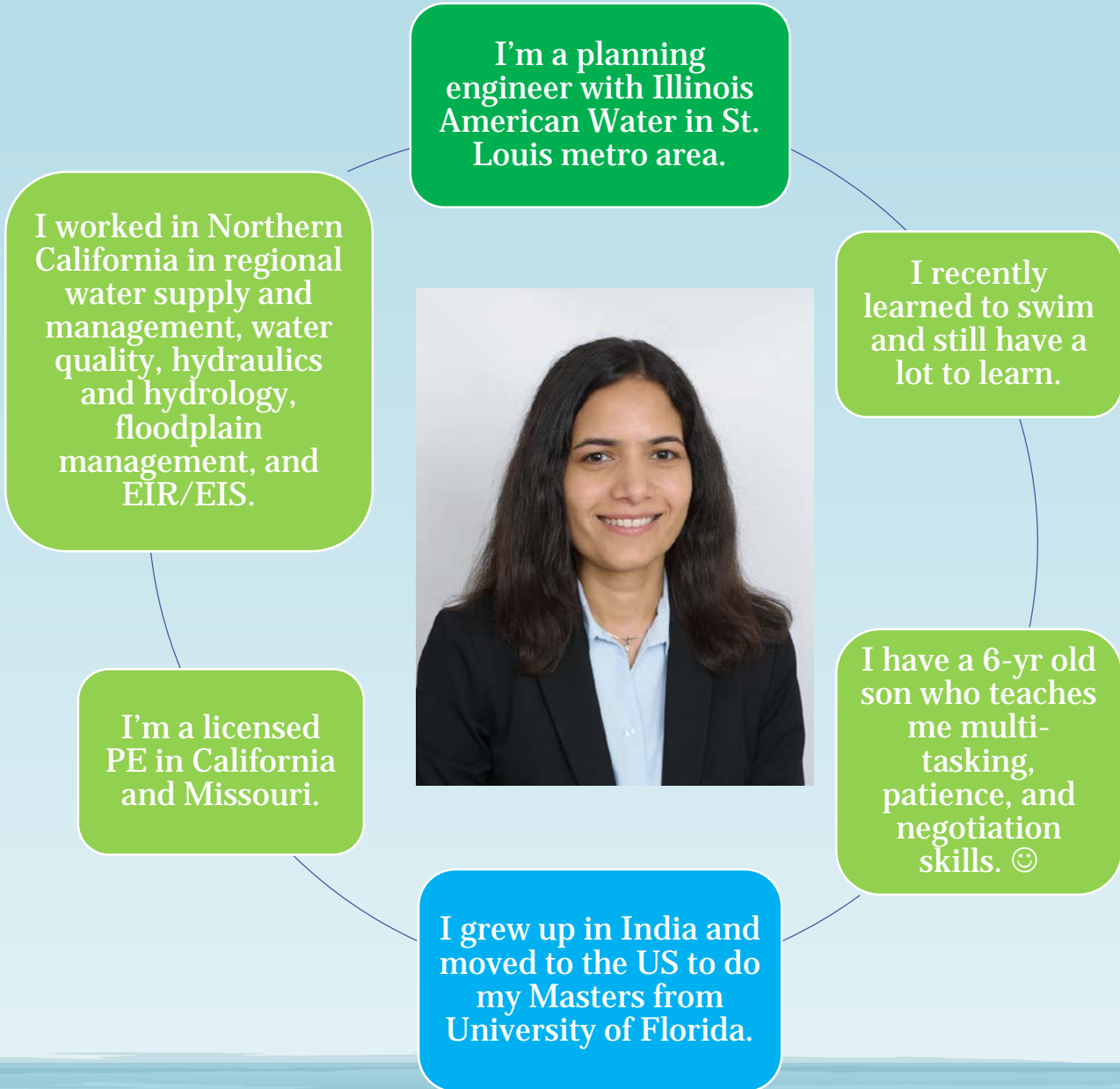

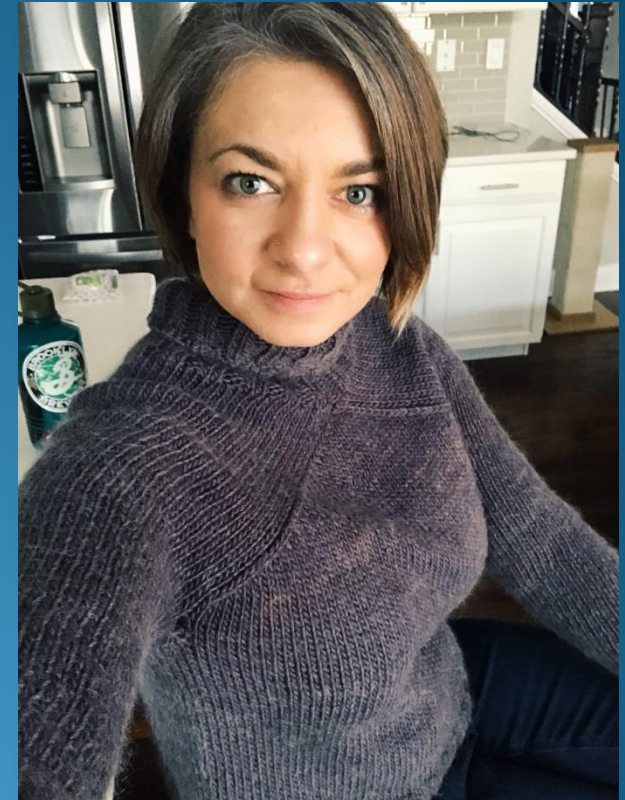

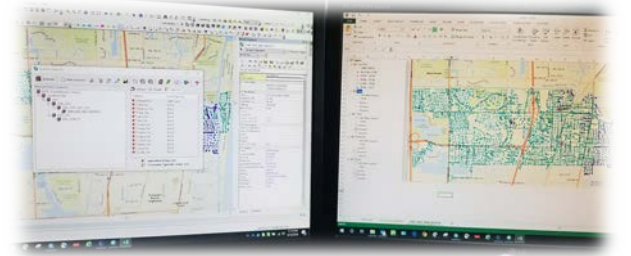
