2020 Midyear Meeting Details:

The 2020 Midyear Meetings will be held in San Antonio, Texas from February 5 through 8, 2020. The meetings will be held at the Hyatt Regency Riverwalk (123 Losoya Street) in San Antonio, Texas.

Hotel reservations will be made by and billed directly to WEF; however, expenses for airfare and meals will need to be purchased by the Participant and submitted for reimbursement through a WEF expense report after the meeting. Itemized receipts shall be furnished for eligible expenses. Participants will share a room with at least one other Participant, allowing the Program to be offered to as many scholarships as possible. Lodging is not offered for local Participants. Efforts will be made to cover all expenses to and from the Midyear meeting. The benefits of attending the Midyear Meeting as a Participant will be offered to each YP for a maximum of two years. WEF provides these scholarships for YPs to increase engagement in WEF activities beyond SYPC. To support these efforts each participant will be asked to adhere to a Code of Conduct during the Program while representing the SYPC. Code of Conduct will be provided to applicants that are accepted to the Program. Agreement and compliance with the Code of Conduct is required for expenses to be reimbursed by WEF.
